Evaluation for Selection To receive consideration for award, the proposal must meet the requirements set forth in this FOA and be presented with adequate detail to assure the evaluator(s) have a good understanding of the proposed requirement(s). The Technical proposal shall be no longer than 10-pages, font 12 (This page limitation is in addition to all required forms). All questions shall be submitted no later than 8 JUNE 2018 at 2 PM CST.

Basis of Award: All proposals will be evaluated in accordance with the Department of Defense Grants and Agreements Regulations (DoDGARs) § 22.315 Merit-Based, Competitive Procedures. Additionally, all proposals will be evaluated to determine the extent to which each NFE demonstrates a clear understanding of the requirements of the announcement, the Performance Work Statement (PWS), and the FOA. The offeror shall submit a proposal that completely addresses all evaluation criteria and specifically identifies how each requirement will be satisfied.

All factors will be used to assess the merits of the NFE who will receive the award of the Cooperative Agreement. The selection decision will be based upon the merits of each proposal in comparison to each factor.

Note: Each evaluation factor shall be weighed in descending order of importance. The NFE shall address all factors within their submitted proposal.

Initial Review: The Government will perform an initial review to determine that the applicant is:

- (1) eligible in accordance with Section III of the announcement
- (2) all information required by Section IV has been submitted
- (3) all mandatory elements of the PWS are satisfied within the NFE proposal.

Evaluation Criteria:

a. Technical Factor I: Past Project Performance

- i. The NFE will ensure that the proposal outlines the NFE's proven ability to successfully perform programmatic activities and submit reports on time. The NFE shall submit a minimum of two (2) <u>completed projects</u> that demonstrate their ability and knowledge of developing research designs and mitigation plans of archaeological sites. Experience with archaeology of the Southern Plains is desirable for this support. Information collected will be evaluated for:
 - 1. Relevance (Scope, Location, Value);
 - 2. Technical Complexity;
 - 3. Technical Team; and
 - 4. Confirmation of the applicants' performance through installation Point of Contact

b. Technical Factor II: Technical Approach and Schedule

The NFE shall obtain all necessary permits required by the state and federal agencies to perform the tasks associated within the PWS. The NFE will ensure that the proposal outlines the project team for each project.

- i. The technical approach presented shall demonstrate the Offeror's understanding of the archaeology of the Southern Plains.
- ii. The NFE will ensure that the proposal outlines the requirements of the PWS. This factor will be considered satisfactory when the applicant specifically outlines:
 - 1. Technical Approach; and
 - 2. Timeline for project completion within the 18 month Period of Performance

c. Factor III: Cost Review

The NFE shall ensure the total budget proposal does not exceed the funding amount listed in Section II and that the associated costs for the proposal are clear and easily ascertainable by the evaluator(s).

- i. The NFE shall ensure the budget line items are appropriate and reasonable with the level of effort needed to accomplish the tasks listed in the PWS. Cost information shall include:
 - 1. Key Personnel with labor rates;
 - Equipment/Vehicle lease or purchase (with completion of Lease vs. Buy template for each); and
 - 3. Associated travel costs <u>per location</u>, to include (if applicable):
 - a. Estimated flights,
 - b. Hotel Costs,
 - c. Estimated days in travel status,
 - d. Per diem,
 - e. Applicable leases,
 - f. Estimated fuel costs

d. Factor IV: Past Performance

The NFE shall ensure they can exhibit a record of acceptable past performance.

Good	Proposal meets requirements and indicates a thorough approach and understanding of the requirements. Proposal contains strengths which outweigh any weaknesses. Risk of unsuccessful performance is low.
